



## FREQUENTLY ASKED QUESTIONS

### **How do I register people when I am onsite?**

If you have additional staff that you would like to register onsite, please visit the Exhibitor Registration counter on level OE. If you have additional clients that you would like to register, please visit exhibitor registration onsite, and your client may pick-up their badge at attendee registration. Registration will open on Monday at 15:00. Additional exhibitor badges may be purchased for €40 and additional client badges may be purchased for €80. Please be ready to provide demographic information for all clients being registered.

### **Where can I pickup my tote bag?**

Each exhibiting company is entitled to (1) tote bag per company. The primary/onsite contact person listed in the registration database will receive the (1) tote bag. Tote bags will be distributed in booth on Monday morning.

### **Can I pass out fliers in the exhibit hall and lobby areas?**

ALL marketing and promotional efforts must remain in your booth space. Exhibitors that violate this rule will be cited and will lose exhibitor points.

### **Can I have an extra onsite program?**

Yes, you can. Each exhibiting company is welcome to pick up two extra onsite programs per company at the conference registration area.

### **Can exhibitors attend the educational sessions and events?**

Yes, Exhibitor badge holders may attend the educational sessions. They may also attend the Monday night Opening Reception on the Exhibit floor, the General Sessions, and the Keynotes. Exhibitors may attend the Wednesday Night Event, however a ticket must be purchased at exhibitor registration.

### **Can clients attend the educational sessions and events?**

Yes, Exhibitor Client badge holders may attend the educational sessions. They may also attend the Monday night Opening Reception on the Exhibit floor, the General Sessions, and the Keynotes. Exhibitor clients may attend the Wednesday Night event, however a ticket must be purchased at exhibitor registration.
